Terms and Conditions

- Exhibitor agrees to exhibit only products which it manufacturers, represents or distributes, comprising of materials, equipment, apparatus, systems, services and other component products applicable to improving developments, techniques and applications in tight gas prospects.

- The individual signing this agreement warrants that the product to be exhibited qualifies for the exhibition. If SPE later determines that such product in fact does not qualify for the exhibition, SPE can cancel the space and contract without any refunds.
- Exhibit space will not be assigned until full payment in U.S. dollars has been received.
- SPE Show Management will assign exhibit space on a first-come, first-served basis.
- Should an exhibitor elect to cancel their exhibit space prior to 2 February 2008, the exhibitor will be assessed a cancellation penalty equal to 25% of the total cost of contracted exhibit space, and 100% after 2 February 2008. No refunds will be made after 2 February 2008. Cancellations must be received in writing.
- Exhibitor agrees not to assign, sublet, or apportion the whole or any part of the space allotted to Exhibitor, nor exhibit therein, nor permit any other person or party to exhibit therein.
- The exhibit space cost includes: standard booth draping (8-ft. high back wall and 3-ft. side rails) and an ID sign.
