Temporary Transfer of Copyright

Policy

SPE's policy is to safeguard contributed works by obtaining copyright on papers submitted for peer review. This process allows dissemination of the information by SPE for review purposes while maximizing your protection against infringement by third parties. Under terms of U.S. copyright law, SPE must obtain a written, signed transfer of copyright from the original owner of the work. The author is assumed to be the owner unless the work was done within the scope of the author's employment, in which case, the employer¹ is the owner.

Upon execution of this transfer, SPE shall own exclusive² rights to the work, including the right to reproduce it and to distribute it. Under the terms of this agreement, SPE will distribute the work only for review purposes and will not distribute it through the SPE Book Order Department, list it as available from SPE in the *Journal of Petroleum Technology* or the SPE Index, or include it on the SPE MasterDisc or the SPE Microfiche Collection. **If the SPE Editorial Review Committee determines that the work does not meet its peer review standards, full copyright will revert to the original owner.** Should the work be approved by the SPE Editorial Review committee, the author(s) or employer will be asked to sign a permanent transfer of copyright to SPE before the work will be considered for publication or distribution by SPE.

YOUR RIGHTS

During the term of this agreement, the author retains the rights listed below.

1. The nonexclusive³ right to make an oral presentation of the same or similar material.
2. The work is original and is not copied from other works.
3. The author is the owner of the work and has not transferred ownership of any part of it to any other person or organization.
4. If the work was done in the scope of the author's employment, the author has the employer's explicit permission to transfer copyright or the employer's agent has signed. If claiming Government Exemption, the author warrants to SPE that the work is original and not copied from any other published work(s).
5. The work does not contain any unauthorized trade-secret disclosures.
6. This paper will not be submitted for review or publication elsewhere while under review by SPE.

²The term "exclusive" refers to all the rights enumerated in Sec. 106 of the U.S. Copyright Revision Act of 1976.

³The term "nonexclusive" refers to the rights that SPE and the author can exercise concurrently.
