- No sponsorship will be acknowledged or promoted, either in print or on the SPE official website, until the contract and required deposit has been submitted.
- Payment is accepted in US dollars only. SPE also accepts most credit cards, checks, money orders and wire transfers.
- Should a sponsor elect to cancel a confirmed sponsorship, SPE is not entitled to refund the monies paid to SPE.
- Company representative signature binds the company to the payment and cancellation schedule. If the company cancels participation with money
  due, the outstanding funds will be due upon cancellation.
- Prices do not include sales taxes. Sponsoring company is responsible for any local taxes and fees.

#### DEADLINES

#### In order for sponsorship to be promoted in the Workshop Technical Program:

- Sponsorship Contracts and payment must be received prior to 9 August 2023
- Sponsor logos should be sent as vector based .EPS or .Al files, 4 color process
- If a vector based logo does not exist use the following file recommendations:
  - Logo should be at least 2 inches wide when produced at 300 pixels per inch
    - Logo should be submitted as a .TIF or .EPS file formats
